This certificate cannot be used for transaction of commodities. All organic transactions should be disclosed to Biocert International Pvt Ltd in advance. This certificate of compliance is valid till 29.11.2021 The next inspection of your unit is due before the expiry of certificate of compliance, so kindly renew the certification well in advance. In case of non-fulfilment of the annual inspection, the certificate will be cancelled. The product may be labelled or marketed according to the certification status indicated in "Certificate of Compliance". Copy of label you shall get approved from Biocert Certification department and for your reference I have attached sample copy of label.; only approved label shall be used. For the export of certified organic products to EU countries, the certificate of inspection (COI) is mandatory and Biocert International shall issue the electronic certificate of inspection through Trade control and Export System (Traces). Operator must apply the COI, before or at the moment of the consignment leaves the country of export or origin with all the necessary documents. After receiving of COI application Biocert will take minimum 7 working days to issue the certificate of Inspection. After issuance of COI, within 10 days all the information concerning transport means and the transport documents shall be included in the COI/TRACES, or in any case, before endorsement of the COI from Member State's authorities. All operator shall send the transport information- original colour copy of BOL within 10 days from the issuance.

Biocert International shall not issue COI

- After expiry of certificate of compliances until the renewal of certification process completed by the operator.
- In case of follow up visit/additional inspections of the operations, if Biocert International found any major noncompliance then until all the non-compliances closed by the operator in between validity of certificate.
- In case of notification of infringement/irregularity/fraud cases, then in such cases also Biocert International shall not issue COI to the same lot of remaining quantity until completion of the follow up procedures and reply to OFIS

As per the current scenario of ETO detection in export produce from India, Guidelines on additional official controls on products originating from India sent to you on dated on 4th June 2021, and with reference to the certified product list of **ECOPURE SPECIALITIES LIMITED** following products classified in high-risk crops, hence this is mandatory to do sampling and testing of each export consignment of following crops

Along with this *Please Note all the export shipment samples (High Risky/Non-High Risky Crops) shall be drawn by Biocert International representative before approval of COI.
